

EXPLANATION OF TERMS AND SYMBOLS



Introduction

The Q-SYS NV-1-H-WE wall-mount HDMI encoder enhances and extends the NV Series network video distribution into flexible and reconfigurable spaces, providing a single platform for network video distribution across every room type. The NV-1-H-WE can be used alongside other Q-SYS NV Series network video endpoints, providing system design flexibility. Like all Q-SYS products, the NV-1-H-WE offers native integration into the Q-SYS platform, reducing complexity and accelerating deployment by tightly integrating device configuration, control and audio routing capabilities.




NOTE: NV-1-H-WE network video endpoints require a Q-SYS Core processor and Q-SYS Designer Software (QDS) version 9.13 and later for configuration and operation. Information about the QDS components related to the NV-1-H-WE, including their properties and controls, can be found in Q-SYS Help at help.qsys.com. Or, simply drag an NV-1-H-WE component from the Inventory into the Schematic and press F1.

Power Requirements

- 802.3at Type 2 Class 4 PoE+ (30W from PSE, 25.5W at NV-1-H-WE) power input required.
- You must follow the safety instructions for the PSE.
- The PSE power supply cord shall be connected to a socket-outlet with an earthing connection.
- The NV-1-H-WE is intended to be powered by a Listed (Certificate) power supply compliant with LPS or PS2, output rated 56 VDC, 0.42A minimum (PoE), maximum ambient temperature (TMA) of 40 C°, and maximum altitude of 2000m. Contact QSC if assistance is needed.


Connections and Callouts

Front Panel



- 1. **HDMI In** HDMI 2.0 input with support for HDCP 2.3 and HDCP 1.4.
- 2. **Reset Button** (Behind perforated cover, recessed) Use a paper clip, or similar tool, to press and hold the reset button for 10 seconds to reset the NV-1-H-WE to factory values.
- 3. **Power/ID LED** Illuminates blue when the NV-1-H-WE is powered on. Blinks green when placed into ID Mode via ID Button or Q-SYS Peripheral Manager. Solid Green indicates valid HDMI input.
- 4. ID Button (Behind perforated cover) Locates the NV-1-H-WE in Q-SYS Designer Software and Q-SYS Peripheral Manager.

Rear Panel



1. **LAN / PoE** – RJ-45 connector, 2.5GbE, 802.3at Type 2 Class 4 (30W from PSE, 25.5W at NV-1-H-WE. For connection to Q-LAN.

Installation


The NV-1-H-WE is designed to be installed into dual gang electrical boxes that are common in North America. A variety of alternate electrical boxes and brackets with similar mounting hole placement may be accommodated, though mounting procedures for these alternate solutions are not documented here.

Ensure installation meets the following:

- Environment A per IEEE 802.3at
- Wiring methods and materials shall be in accordance with NFPA 70, the National Electrical Code (NEC), in particular Section 725.130.
- Conductors and equipment shall be installed in accordance with NFPA 70, the National Electrical Code (NEC), in particular Section 725.133.

Clearance Requirements

A dual gang rectangular box with minimum dimensions shown in **Figure 3** is recommended. For more information, refer to the product drawings at asys.com.





Ventilation Requirements


IMPORTANT! Ensure that the inflow and outflow perforations do not become blocked.

Installation Steps

- 1. Connect the network cable to the LAN / PoE port on the rear of the NV-1-H-WE.
- 2. Ensuring that the NV-1-H-WE is oriented in the "up" direction (with HDMI connector on the bottom), attach the unit to the dual gang electrical box using the four (4) pre-attached 6-32 x 3/4" screws.
- 3. From the Decora Screwless Wallplate Kit, attach the subplate to the NV-1-H-WE using the provided screws from the kit.
- 4. Snap the Decora Screwless Wallplate onto the unit to complete the installation.








Perforated Insert Cover Replacement

White Perforated Inserts can be swapped out with the Black Perforated Inserts to match decor.

To remove existing white insert, pinch the bottom of the insert and rotate the bottom of the insert upwards to remove.

To install the new insert, angle the top of the insert into the slot towards the top and rotate downwards until the insert clicks into place.
